

2022 ITC Awards for Excellence in eLearning - Early Career Distance Educator or Staff Member

Nomination Deadline: Monday, October 17, 2022

ITC will recognize every distance educator or staff member nominated for this award, chosen by their institution as an exemplary member of their community. We encourage nominations to be submitted by their institution's President/CEO, Provost/Academic Vice President, or Dean with a limit of one nominee per institution. *The nominee will have demonstrated less than 10 years of dedication to higher education.*

The distance educator must have taught at least two fully-distance learning classes in the past year. Documentation of their outstanding teaching and class management strategies, along with course success rates and other pertinent information, is required. The documented teaching and/or course management strategies must be replicable and of value to the teaching profession.

The staff member should have a demonstrated track record of excellence in distance education and provide examples of their efforts.

A panel of ITC judges will choose ONE or TWO exemplary distance educators or staff members to receive ITC's 2022 Outstanding eLearning Legacy Award for Distance Educator or Staff from the pool of nominees. ITC will provide discounted registration to these one or two outstanding recipients to attend the ITC 2023 Annual Conference - eLearning in Las Vegas, NV.

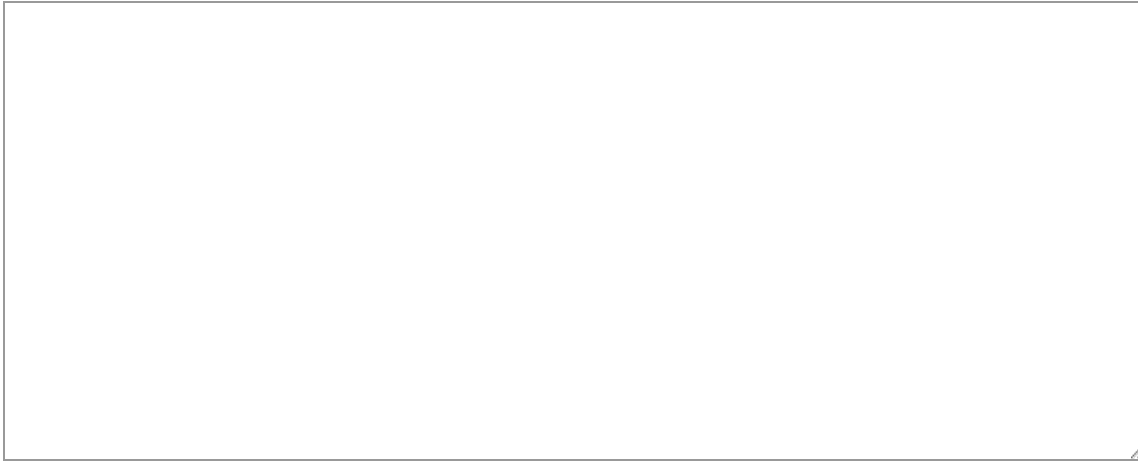

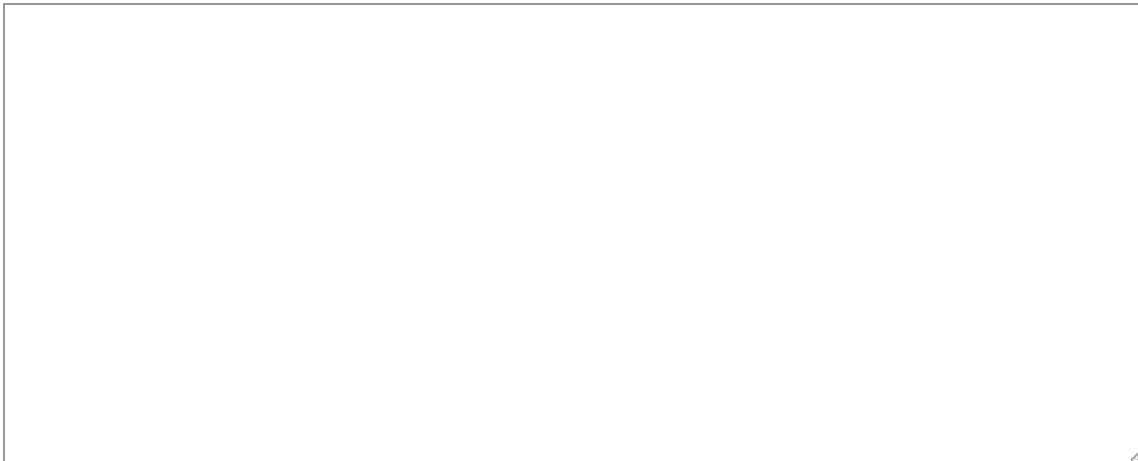

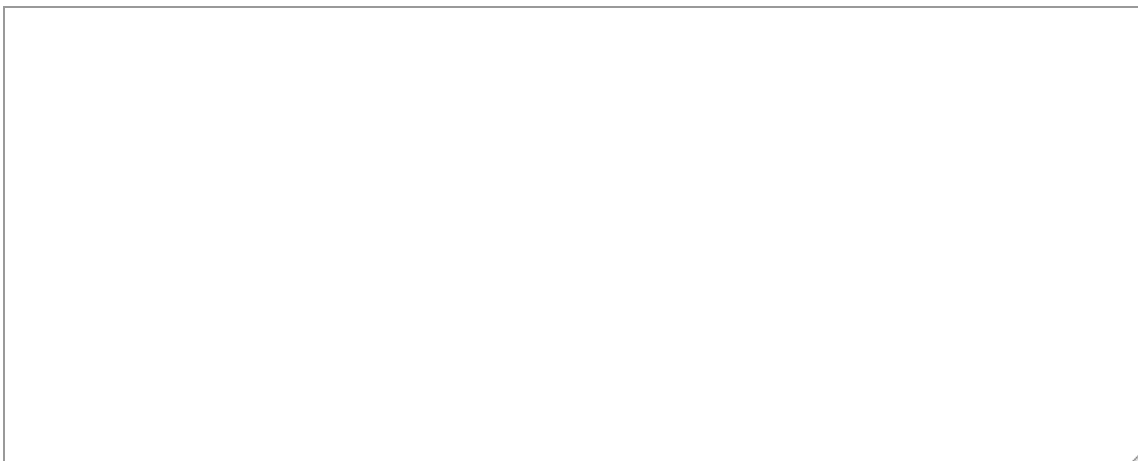
